## **FOI REQUEST - REFERENCE NUMBER 2014-028**

I refer to your request for access to documents under the *Freedom of Information Act 1982* (the FOI Act) in your email of 16 September 2014. Specifically, you have sought access to the following:

"... the number and purpose of Comcar trips taken by Mark Scott in 2013 and 2014."

I am authorised by the Managing Director under section 23 of the FOI Act to make decisions in respect of requests made under that Act. Following is my decision in relation to your request.

## Locating and identifying documents

I have taken reasonable steps to identify and locate all relevant documents. My search for these documents involved contacting the Managing Director's Chief of Staff, who in turn consulted with relevant staff within the Managing Director's office.

I requested that searches be conducted of all hard and soft copy records for documents which fall within the scope of your request. As a result of those searches, the following 14 documents were identified:
