Entry Method (Clause 5)	To enter, Applicant/s must complete the relevant form on the ABC Radio Brisbane website and meet all Entry Requirements (Clause 4).
Maximum Number of Entries (Clause 7)	<ol style="list-style-type: none"> 1. A member of the public may only vote once for their People’s Choice selection 2. A unique vote will be determined via a unique email 3. If a person submits more than one vote from a single email, then only their first vote will be counted.
Judging Details (Clause 8)	The People’s Choice winner will be determined by the person who has the highest number of valid votes.
Prize (Clause 9)	The winner/s of the of the ABC Radio Brisbane People’s Choice award will receive a certificate and trophy. Each finalist will receive a certificate. Due to Covid-19 restrictions certificates may be posted to the finalists. The Prizes will be presented to the award winner/s at the Community Spirit Awards on Friday 5 November 2021.

General Terms and Conditions

Introduction

- By entering the Competition, you agree to be bound by the Terms and Conditions of the Competition. The Terms and Conditions governing the Competition include these General Terms and Conditions, the Schedule to these General Terms and Conditions and any instructions relating to the Competition on the Promoter’s website (**Website**).
- Any capitalised terms used in these General Terms and Conditions have the meaning given in the Schedule, unless stated otherwise. In the event of any inconsistency between the Schedule to the Terms and Conditions (**Schedule**) and these General Terms and Conditions, the Schedule will take precedence.
- The Promoter may in its absolute discretion refuse to award any Prize to any Nominee who fails to comply with these Terms and Conditions.

Entry Restrictions

- Eligibility to enter the Competition is subject to the Entry Restrictions. An Entrant of the Competition must be an individual and not a company or organisation. Directors, employees and contractors of the Promoter and any agencies, retailers and suppliers directly associated with the Competition, or with the provision of the Prize and any of their immediate family members (including spouse, defacto spouse, parent, child or sibling (whether full, half, step or by adoption)), are not eligible to enter.

Competition Period

- The Competition will be conducted during the Competition Period. Any Application received after the expiry of the Competition Period will be deemed invalid. No responsibility is accepted for late, lost, delayed or misdirected entries.

Entry Method

- To enter the Competition, Applicants must enter the Competition in accordance with the Entry Method (and any other entry details provided by the Promoter on the Website) during the Competition Period. Nominees who are selected as finalists must enter in accordance with Entry Method (and any other details provided by the Promoter) after being notified that they have been selected as a finalist.

Maximum Number of Entries

- Entrants can enter the Competition up to the Maximum Number of Entries. Entries must be submitted separately and each entry must individually meet the requirements in the Schedule and are subject to the Entry Restrictions.

Judging Details

- The award of the Prizes will be determined in accordance with the Judging Details in the Schedule. The Promoter and its panel of judges may, in their absolute discretion, decline to nominate any finalists or award any or all Prizes, including where the judges determine that the entry is not of publication standard. Chance plays no part in determining the Prize winners. Decisions of the Promoter and its panel of judges are final and will be binding on each person who enters the Competition and no correspondence will be entered into.

Prize

- The Prize will be awarded as specified in the Schedule. The Prize values (if indicated) are the recommended retail value as provided by the relevant supplier, are in Australian dollars and are correct as at the time of the commencement of the Competition Period. The Promoter accepts no responsibility for any variation in the Prize value.

Prize Restrictions

- Unless otherwise specified in the Schedule, the Promoter will not be responsible for any additional costs associated with use of the Prize.  - (b) the right to publicise, broadcast and communicate to the public your name, character, likeness or voice for any promotion or matter incidental to the Competition with no compensation to you for such use.
19. You understand and agree that your entry may be edited or adapted at any time by the Promoter for legal, editorial or operational reasons.
20. As a condition of accepting the Prize, the winner must sign any legal documentation as and in the form required by the Promoter and/or Prize suppliers in their absolute discretion, including but not limited to a legal release and indemnity form.

ABC Material

24. Any attempt to interfere with the normal functioning of the Website or to otherwise undermine the legitimate operation of this Competition is prohibited and will render all entries submitted by that entrant invalid.
25. You warrant that:
- (a) your entry is your original work, and to the extent it is not, you have obtained the relevant permission;
 - (b) all details provided with your entry are true and accurate;
 - (c) you have all necessary rights to grant the Promoter the rights granted under these Terms and Conditions;
 - (d) use of your entry by the Promoter, in accordance with these Terms and Conditions, will not infringe the rights of any third parties; and
 - (e) your entry does not breach any law.
26. You agree to indemnify the Promoter against any loss or damage resulting from any breach of the warranties above and acknowledge that the Promoter may, in its absolute discretion, not award the Prize to you for breach of the warranties above.

29. If there is any event that prevents or hinders the Promoter's conduct of the Competition or the Promoter's ability to deliver the Prize to the Prize winner(s), the Promoter may, in its discretion, cancel the Competition and recommence it at another time under the same conditions.

The Promoter is not responsible for any incorrect or inaccurate information, or for any failure of the equipment or programming associated with or utilised in the Competition, or for any technical error that may occur in the course of the administration of the Competition. The Promoter assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorised access to or alteration of entries.
