
Recently the ABC Lateline program aired a hit piece on Pauline Hanson's One Nation party, where Mr Kim Beazley declared our party a "threat to national security".

Mr Sean Black, the delegated representative for One Nation, subsequently requested a right of reply to re-dress these gross misrepresentations. Astonishingly Lateline's executive producer, Ms Whitby, and reporter Mr Lipson, have refused to allow us the opportunity to respond to these prejudiced and misleading on-air slurs.

In spite of having requested this right of reply on a number of occasions Sean have been informed that the right of reply will only be given to Senator Pauline Hanson. On this occasion however Senator Hanson is not available and has delegated the right of reply to Sean on behalf of One Nation, which is her prerogative to do so. Without an opportunity to a right of reply we are unable to respond to these outrageous miss-truths and ABC viewers are left with an unfair and unbalanced perspective.

As the nation's broadcaster I request that the ABC continue to adhere to its charter and ensure that maligned political parties maintain access to their right of reply which also ensures ABC viewers are afforded an opportunity to access the full story.

Dear Senator Roberts,

Your letter to Mr Millett has been passed on to me, in my capacity as Editorial Director of the ABC.

I note that Mr Beazley, towards the end of a long interview on Lateline about US foreign policy, made some comments about One Nation in the wake of the WA preference arrangements.

I further note that, a couple of days later, Lateline acknowledged on air that you had taken issue with those comments on behalf of One Nation and produced a video on Facebook responding to the comments. An excerpt of that video was played on the program.

Under those circumstances, I can't see any obvious breach of the ABC's editorial policies in any respect.

I would remind you, though, that the ABC has a complaints process for anyone who feels we have breached our editorial standards, and if you are dissatisfied with my initial view I would invite you to lodge a formal complaint and it will be investigated.
