# Beetaloo Basin TOs: NT govt approves new Origin wells Tamboran forces access on Rallen cattle station

Nurrdalinji Aboriginal Corporation vows to consider legal and other options New photos available of Tamboran forcing access onto Tanumbirini cattle station

**WHAT**: On the same day Reconciliation Week begins, the new NT Fyles government has approved four new Origin fracking wells in the Beetaloo Basin. Meanwhile, Tamboran Resources has commenced bringing heavy work equipment to cut fences onto Tanumbirini cattle station, clearing land to build a road and new well dangerously close to Newcastle Creek which is protected by sacred sites legislation.

Tamboran has today forced access to Tanumbirini station, cutting fences and moving heavy equipment onto Rallen Australia's cattle station. Rallen has given no consent and the gas company is proposing construction of a new access track

Statement from Gudanji-Wambaya man Johnny Wilson, Chair of Nurrdalinji Native Title Aboriginal Corporation:

"We are heartbroken that the Northern Territory Government is letting Origin do more fracking, on the

same day that Tamboran Resources is cutting gates and bringing heavy machinery onto our country on Tanumbirini Station without our consent.

"This is our country, our family and our future. Everything that is important to us is in grave danger. We will use all means and measures to stop this.

"We are working with our lawyers and Rallen Australia to consider all options, including immediate legal interventions.

"As Reconciliation Week starts it's insulting that fracking plans which are actively opposed by Traditional Owners are being announced.

"Today we have suffered two new blows. We have repeatedly said we do not want this fracking, but the government and gas companies are ignoring us and putting money before our right to preserve country, sacred sites and water.

"Our people have deep connections across the region. We don't want to see this one-by-one consideration of new wells, new fracking. Our clans and families talk to one another and are becoming more and more worried that this fracking is occurring right across the area.

"If the water is impacted in one part of our country it ultimately impacts on the story and song further away."

## About Nurrdalinji

The Nurrdalinji Native Title Aboriginal Corporation includes native title holders from the Amungee Mungee, Beetaloo, Hayfield, Kalala, Newcastle Waters - Murranji, Nutwood Downs, Shenandoah, Tandyidgee, Tanumbirini, Daly Waters Township, Ucharonidge native title determinations.

The Beetaloo sub-basin is located around 500 kilometres south-east of Darwin. It embraces Aboriginal land, pastoral leases (which co-exist with Native Title rights and interests), horticultural enterprises, cattle stations and remote Aboriginal communities. A number of companies are currently undertaking fracked gas drilling in the region, with most of the NT covered by exploration permits.

#### **Tanumbirini**

Tanumbirini is a 5,000 square km cattle station located near Daly Waters, 600km southeast of Darwin. Tanumbirini's owners Rallen Australia are one of Australia's largest landowners. They are in a legal dispute with Sweetpea Petroleum, a subsidiary of Tamboran Resources. Tamboran has an exploration permit (EP 136) for exploratory fracking that covers parts of Tanumbirini and the neighbouring Beetaloo Station.

## Nurrdalinji

The Tanumbirini owners and local Traditional Owners, supported by <u>Nurrdalinji Native Title Aboriginal</u> <u>Corporation</u>, are united over concerns about fracking risks to land, water and sacred sites. Nurrdalinji has

been working closely with Rallen in a bid to protect their country for future generations. Both are vocal about a consistent failure by fracking companies to properly consult about their plans.

Nurrdalinji's Board has spoken out in public hearings and made submissions to government inquiries and in response to fracking companies' plans, including submitting comments on Sweetpea's draft Environmental Management Plan for EP 136. Nurrdalinji has expressed concerns about the potential of Tamboran to damage sacred sites and destroy country, water and culture on Tanumbirini. Tamboran's Sweetpea has failed to conduct stakeholder engagement with Nurrdalinji on any of its EMPs.

#### **Access**

Following a failure to reach agreement about land access to Tanumbirini, the NT Civil and Administrative Tribunal (NCAT) determined an access agreement for Tamboran and neighbouring Beetaloo Station on 4 May 2022. Tanumbirini and neighbouring Beetaloo Station are appealing, with a hearing scheduled for the NT Supreme Court on 20 June 2022.

This access agreement allows Tamboran to begin exploration works, and the company has given notice it intends to access Tanumbirini from Wednesday 25 May - the first company to do so since the commencement in January 2021 of new NT Petroleum Regulations which are designed to provide minimum protections to landowners, including pastoralists, in negotiating land access and compensation arrangements with petroleum companies. In this case, existing access may prove difficult, with the exploration area landlocked and access requiring Rallen's consent and there being no consent to clear a new road.

Rallen has given no consent to Tamboran travelling through no go zones near its water infrastructure, and the gas company is now proposing construction of a new access track on Tanumbirini which Rallen has seen no approval for from the Minister for Environment.

## Tamboran mired in controversy

Tamboran faces financial challenges. Its 100% owned subsidiary, Sweetpea Petroleum, was purchased by Tamboran Resources, but Sweetpea's US investors maintain a 30% ownership of Tamboran through a shell company, Longview Petroleum LLC, which is registered in Delaware in the US, a known tax haven, via the notorious Corporation Trust Centre home to a reported 300,000 companies. Sweetpea was controversially granted \$7.5 million in public money for exploration by the Morrison government in March 2022. Tamboran is under threat of being referred for contempt of the Federal Senate for refusing to appear before an Inquiry into Fracking in the Beetaloo Basin, with its critics pointing to its failure to be publicly accountable for this grant.

Tamboran's Environmental Management Plan (EMP) for EP 136 for drilling and fracking has not yet been approved. It was <u>withdrawn by the company</u> in March 2022, following complaints about Tamboran's failure to properly consult with impacted parties. A <u>revised EMP</u> is now open for public consultation until June 20.

"We've had three years of Santos, Origin and Tamboran on our station and we're seeing that if the full development occurs into production that fracking and cattle don't mix. The government is doing nothing to ensure companies comply with regulation.

Rallen Australia Director, Pierre Langenhoven said, "In backing this controversial industry, the government risks wrecking the NT's water and the cattle industry, which has long been the economic backbone of the NT.

## Why is the case important?

<u>Sweetpea is the first company</u> to force access without the consent of pastoralists since the commencement in January 2021 of new NT Petroleum Regulations, designed to provide minimum protections to landowners in negotiating land access and compensation arrangements with petroleum companies.

In January 2022 Rallen won a NT Supreme Court battle against Santos for its failure to inform Rallen of plans to drill additional wells on its property.

## **About the Supreme Court Appeal**

Following a failure to reach agreement over Sweetpea's bid to access neighbouring cattle stations - Tanumbrini and Beetaloo Station - the NT Civil and Administrative Tribunal (NTCAT) determined an "access agreement" for Tanumbrini on 4 May 2022. There is no set decision date.

Rallen Australia has eight grounds of appeal. Key grounds include that the access agreement as determined by the NTCAT imposes lesser standards on Sweetpea than the standard minimum protections required under NT law, and fails to balance the interests of the parties by allowing an open scope of activities for an indefinite period of time.

Another ground of appeal is the NTCAT's failure to recognise and provide sufficient protections for the water infrastructure network established on the property. Water infrastructure is essential to the pastoral operations on the land and damage to that infrastructure can put stock at risk.

Rallen also challenges the NTCAT's interpretation of the condition imposed on the exploration permit granted to Sweetpea that it conduct its activities so as not to interfere with the rights and activities of any other person. The NTCAT read this condition down to allow the interference of Sweetpea's activities on Rallen's operations, on the assumption that exploration activities will necessarily interfere and must be permitted. In so doing the NTCAT gave priority to the explorer's interests over the pre-exising interests and

obligations of the pastoralist, rather than seeking to find a balance that might enable co-existence so far as that is possible.

Rallen filed expert evidence demonstrating that the economic loss for the pastoral business from Sweetpea's interference based on the activities it proposes will be at least \$1m/year and ongoing for the seismic activities alone, and if the 7 well program goes ahead, \$3.5m over 5 years, assuming that Sweetpea will rehabilitate in the 5 years, which Rallen doubts is possible.

Rallen states these losses make Rallen's current pastoral business model unsustainable.

The NTCAT found there would be no decrease in market value to the property as a result of Sweetpea's activities. Rallen is challenging that aspect of the decision. The determination was contradicted by the evidence that had been filed, was made on assumptions that were incorrect, and extended to activities that are as yet unknown, under an access agreement with unlimited scope and an indeterminate term.

## To attribute to NT Minister for Environment, Climate Change and Water Security Lauren Moss:

In 2018 the Scientific Inquiry into Hydraulic Fracturing, chaired by Justice Rachel Pepper, independently concluded in its final report that industry risks could be managed if all of the Inquiry's 135 recommendations were implemented.

Over the past four years the Territory Government has been working to implement those recommendations by undertaking comprehensive baseline studies and developing strong regulations and monitoring of an onshore gas industry in the NT.

In April 2023 the <u>Strategic Regional Environmental and Baseline Assessment</u> (SREBA) for the Beetaloo Sub-basin was released, accounting for 35 of the Inquiry's recommendations. The SREBA provided the information necessary to make appropriate decisions about the development of an onshore shale gas industry in the Beetaloo region, including assessment of water and biodiversity resources to inform land-use planning and the collection of baseline data to enable ongoing monitoring.

In May 2023 the Territory Government released the <u>Final Implementation Report into the Scientific Inquiry into Hydraulic Fracturing</u> with a \$2 million annual investment to rigorously assess Environmental Management Plans, deliver a strong compliance program and provide education and guidance to industry.

The Territory Government is moving to carefully manage the onshore gas industry through our strong regulatory framework, ensuring an onshore industry will be operating to world's best practice with new measures to create a sustainable environment. The Northern Territory Budget outlined an investment of \$3.9 million towards ongoing funding to bolster the capacity of the Petroleum Operations unit and the Environment Assessment Unit.

- Mr Wright's observations do not take into account the entirety of the regulatory regime for the onshore gas industry, and in particular the requirement for a mandatory agreement between the gas company and the pastoral leaseholders. This is a private agreement that sets out how those parties interact. The environmental regulator is not a party to that agreement.
- There is no requirement to notify stakeholders when penalty infringement notices are issued.
- There was no environmental harm in relation to the incidents that were the subject of the infringement
- The regulator followed its regulatory processes and requirements under the Regulations. More information on the Division's approach to issuing penalty infringement notices is available in the Division's Enforcement guideline
- All penalty infringement notices issued under the Petroleum Act are published in the annual report.

ABC TV's 730 program is preparing a report on gas developments in the Beetaloo Basin, the economic opportunities and the environmental challenges ahead.

As Justice Pepper's 2018 report found, the shale gas industry has transformed energy markets around the world, but in some cases these changes came with costs in the form of poor environmental outcomes. So the successful management of these environmental risks is critical to the success of the development of the Beetaloo Basin.

With this in mind, we're requesting an interview with the minister. I'm Brisbane based, but we can do the interview via FaceTime with a Darwin crew later this week or early next week if the minister is available.

Also – I have some specific questions about a couple of recent incidents – which is way I've cc'd in the departmental media as well.

According to an incident report (October 1, 2020) – Tamboran Resources (Sweetpea Petroleum) accidentally used a mixture of contaminated water and bore water for dust suppression at the Maverick 1 well pad. What action, if any, did the department take after this was reported? How seriously does the department view this alleged breach?

Also – the Petroleum Operation Unit has been investigating another alleged action causing environmental harm by Sweetpea Petroleum at the Maverick 1 well pad around March 7, 2023, which allegedly resulted in contaminated water being pumped into an open paddock. I understand investigators attended the site on May 3. Has this investigation being completed? What were the findings/outcomes?
